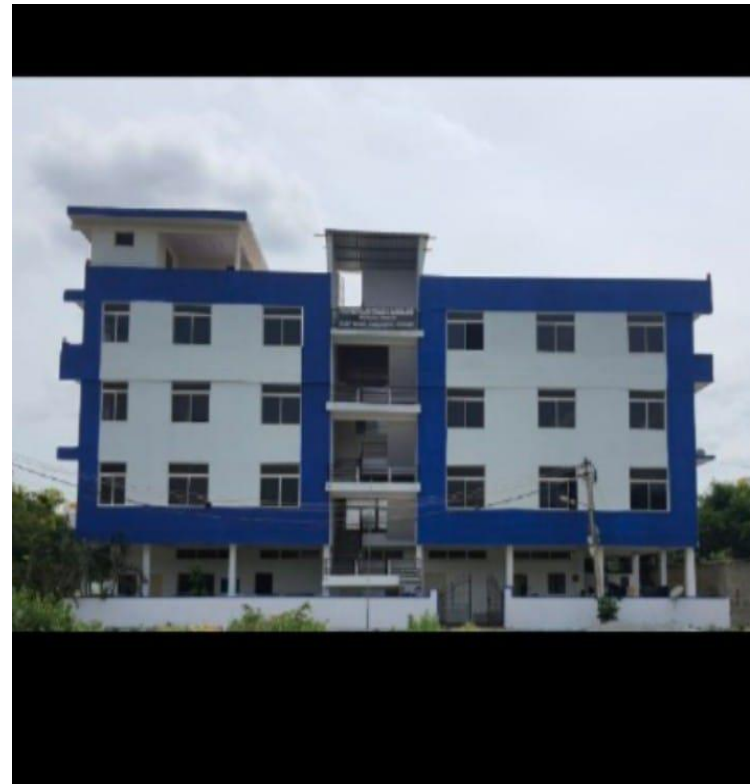

- ✓ Interested Student is required to block seat prior to admission as seats fill up 3 to 4 months prior to admission notifications.
- ✓ Student who is blocking seat shall be provided Seat Blocking fee Receipt, 1st Sem Library Text books and Spiral binded Syllabus book accompanied with past year question papers.
- ✓ Student who has blocked Seat, shall be given 1st preference for Admission during Admission notification issued by University.

Rules For Seat Blocking

- ❑ **Seat Blocking fees shall be paid as decided by management.**
- ❑ **For Fee structure –** Please Call/watsap us at 8197371889/9980856980
- ✓ **Rules for Withdrawal of seat**
- ❖ If any Student decides to Withdraw Seat blocked for admission, then he/she shall be refunded with 50% of Seat Blocking fees, if such withdrawal is one month Prior to Admission Notification issued by University.
- ❖ If student decided to withdraw within one month prior to admission Notification then Such student shall be refunded with 25% of Seat blocking Fees.
- ❖ If student decides to withdraw after admission then he/she shall have to pay entire fees for 3 years and withdraw from Admission.
- ❖ No Excuses or reasons shall be entertained for refund of Fees as against the above Policy.
- ❖ These Rules are strictly enforced by our Management to prevent time-Passers and non-serious Candidates.
